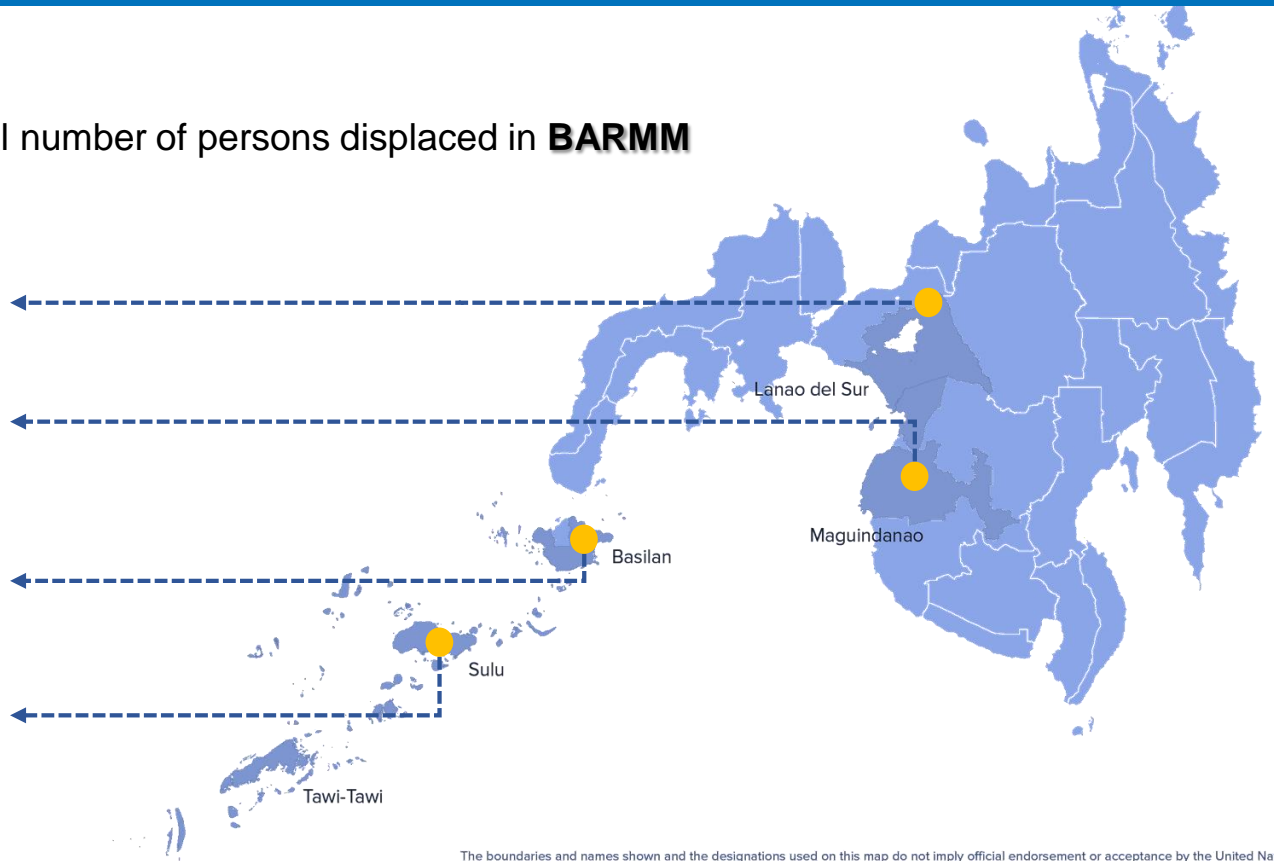

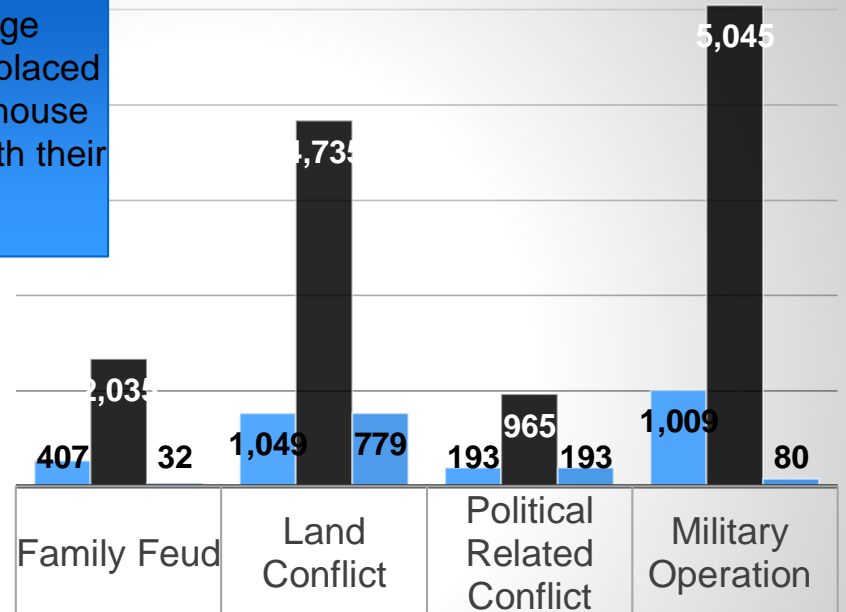

DISTRIBUTION OF FINANCIAL ASSISTANCE THRU AICS

The MSSD-Maguindanao Team visited and interviewed the survivors-casualties and parents of survivor minor casualties and the relatives of the deceased casualties.

A. Php 10,000 worth of Financial Assistance thru AICS were provided to the immediate family member of the three (3) dead casualties.

B. Php 7,000 worth of Financial Assistance thru AICS were provided to those Seven (7) casualties who got major injuries and got hospitalized at CRMC and Maguindanao Provincial Hospital.

C. Php 5,000 worth of Financial Assistance thru AICs were also provided to those casualties with minor injuries and not admitted in the hospital.



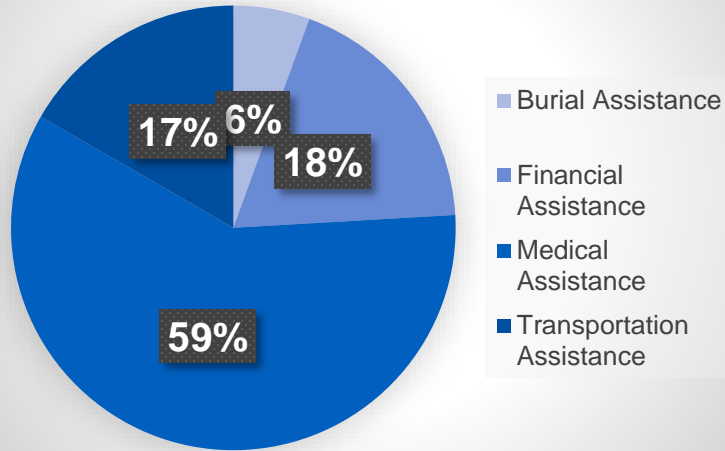

PROTECTION ISSUES

Marawi Displacement

ACCESS TO FOOD AND LIVELIHOOD. The E/GCQ has resulted to disruption of business chain, thereby affecting the IDP retailers due to lack of transportation. This affects the capacity of displaced families to meet their daily needs, including an imbalanced nutrition intake particularly with their children.

ACCESS TO WASH. **Water insufficiency** remains an issue that affects IDPs' personal hygiene and sanitation. The issue on **septic tanks that are full** particularly in Sagonsongan areas still persist. There are families which manually scoop the human excrements (feces) and toss them on the drainage when there is rain, while others connect their septic tanks to the drainage. This increases the health risks of the IDPs.

ACCESS TO BASIC FACILITIES. IDPs have difficulties accessing the basic facilities that they needed due to lack of transportation. The MGCQ allows only one passenger for tricycle and with an increase on transportation cost (this has been an issue even before the COVID-19 and it still persists).

LACK OF CAMP COORDINATOR AND MANAGER. The presence of Camp Coordinator and Camp Manager are needed to facilitate the identification of the persisting issues faced by the IDPs and help on said issues will be responded. The top issues that are related on CCCM are as follows:

- In Sagonsongan Area 5-B, there is an open drainage that is not safe to vulnerable sectors. There is a report that a child fell on the 8-foot drainage;
- Some houses in Division 1 & 4 in Boganga TS are at risk of landslide as their houses are erected in areas which are prone to erosion;
- Landslides have caused mud flood in Boganga TS; and
- Tensions build-up among IDPs.

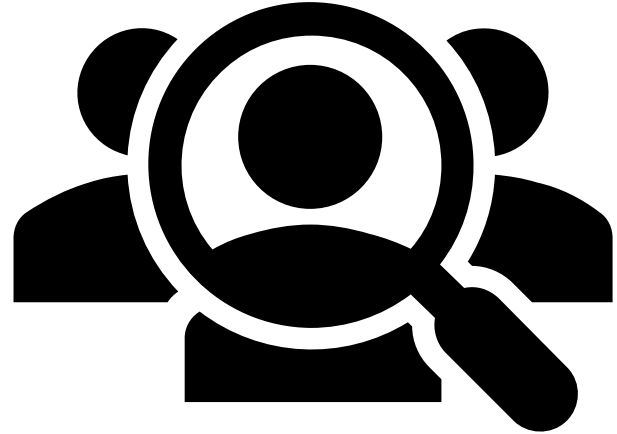

Recommendations of the Sr. Protection Advisor on HLP:

- Housing, Land and Property concerns are at the nexus of Humanitarian work, Development and Peace. The UN Country team should, therefore, have an overall strategy for engaging actors from all the sectors;
- Creation of HLP Platform;
- Strengthen the capacity of BARMM/BTA;
- Develop Advocacy Messages and some Mechanisms to Guide Advocacy on HLP issues in Mindanao



Next Steps:

- Mapping and monitoring of the land disputes that resulted to rido in Mindanao having BARMM as the priority
- Provision of technical support and advices to the Land Dispute Resolution Committee (LDRC) for Marawi
- Mentoring and training to the to be identified members of the pool of mediators, arbitrators and negotiators of the LDRC for Marawi
- Monitoring of the Marawi Compensation Bill and provision of technical support to the authors of the bill
- HLP Forum for Marawi
- Creation of the HLP Protection Platform for BARMM and Mindanao

DISPLACEMENT OVERVIEW IN PATIKUL MUNICIPALITY, SULU PROVINCE

- ❑ Per validation conducted on 17 July 2020 by the MDRRMO of Patikul Municipality, the IDPs are in host families while others have built makeshifts at the displacement sites.
- ❑ A total of 1,078 families were protractedly displaced since 28 July 2017 coming from barangay – Buhanginan, Kabbon Takkas, Maligay, Panglayahan and Pansul. They were ordered to evacuate because of the presence of Abu Sayaff Group (ASG) allegedly hiding in the highland areas. Also, displacements were triggered by insecurities as well as by focused military operations against the lawless elements in Patikul Municipality.
- ❑ Protection issues faced by the IDPs that were presented in the previous meetings still persist.

DISPLACEMENT OVERVIEW IN **BASILAN PROVINCE**

UPDATE ON DISPLACEMENT

- ❑ Number of the protracted IDPs reported in the previous meeting, remains the same.
- ❑ Ten (10) families were displaced in Lamitan City on 15 July 2020 due to family dispute but have gradually returned home on 1 August 2020.

UPDATE ON COVID-19

- ❑ As of 2 August 2020, there were 139 confirmed cases (43 active cases, 95 recoveries and 1 death).
- ❑ On 26-30 July 2020, there were 82 reported Locally Stranded Individuals (LSIs) and 62 Returning Filipinos from Sabah (ReFS) who have arrived in the province.

PROTECTION ISSUES/ CONCERNS

(Additional to the issues reported in previous meeting)

- ❑ Insufficient food for daily consumption of some displaced families.
- ❑ 5 IDP families presently sheltered in government housing project were asked to vacate the houses to accommodate the original occupants who were also IDPs and would wanted to occupy the housing units for better living. (Tabuan Lasa Municipality)
- ❑ IDPs have express the need for core relief items such as housing/tent materials, sleeping kits, flashlights, hygiene kits and water containers.
- ❑ A 40-year old woman died on July 31 who was reportedly infected by the “*sakit ng robot*”. She died in few weeks after being infected of the said sickness.
- ❑ Limited access to potable drinking water. The source of drinking water is deep well because only some are financially capable to buy water.

RESPONSES

(Additional to the responses shared in previous meeting)

- Continuous provision of food assistance.
- Continuous conduct of disinfecting isolation facilities; additional isolation facilities are being constructed.
- Continues manning of quarantine checkpoints
- Resumption of Balik Basilan Program which started on 21 July 2020
- Conduct of medical and dental mission
- Agri-livelihood program for ASG returnees
- Gulayan sa Bakuran Program thru the Provincial Agriculture Office
- Construction of barangay road in Barangay Muslim, Maluso Municipality, and a proposed installation of water system by the government.

Responses/ remarks

Returning Filipinos from Sabah (ReFS)

- The 174 ReFS arrived in Bongao are among the 395 ReFS that were repatriated from Sabah who arrived in Zamboanga City on 30 July 2020.
- The REFs were isolated in Trade School that served as quarantine facility for REFs who will arrived in Bongao. They were provided by the MSSD-BARMM with food that is enough for 14-days quarantine period.
- Sleeping mattress and 200 sacks of rice were provided by the Provincial Governor of Basilan Province.
- Alpha Sigma Phi Omega fraternity donated NFIs such as 14 thermos, 4 electric heater and cups
- IOM has donated sleeping kits and DPWH rations drinking water (50 gallons) every 2 days.

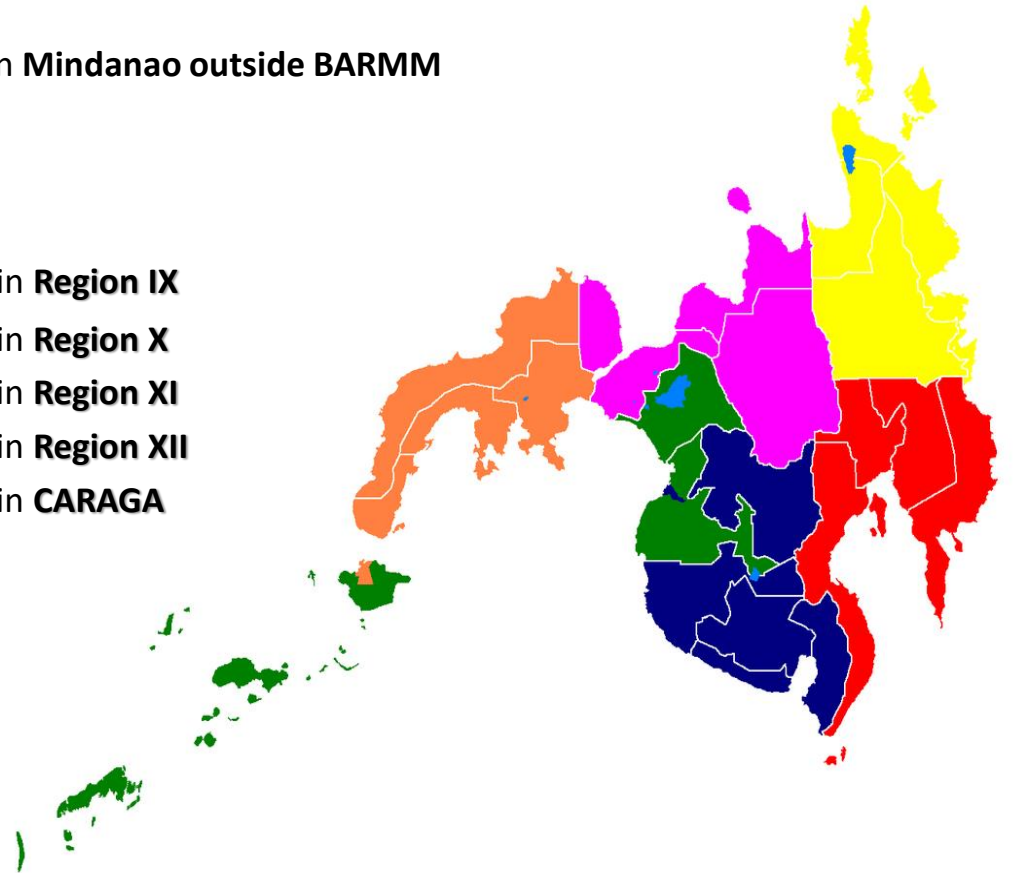
